### 4. Policy Statements

MBM India adopts a multi-pillar approach to sustainability, focusing on the following key areas:

#### A. Sustainable Sourcing & Material Stewardship

- **Regulatory Adherence:** MBM India shall comply with all applicable environmental laws, regulations, and standards (including ISO 14001 guidelines).
- **EHS (Environment, Health & Safety):** We recognize that a safe environment is a healthy environment. We shall provide regular training to employees on chemical handling, spill prevention, and emergency response.
